<u>Rental & Maintenance Update:</u> Becky Girdler said she had 1 more screen repaired. Woodstove re-installation is moving forward, tile still needs to be repaired and new fireboard installed.

<u>Cowboy Church Dinner:</u> Barbara Sarkis moved to set the price of dinner at \$8.00 per person. Elaine 2nd. Motion approved with 2 objections. After discussion and revote, price was set at \$8.00 for adults and \$5.00 for children under 12 years.
